Notification has been received that Planning Application 13/0233/ NCC Mr D Roberts to vary condition 1 of planning approval 10/0019/NCC to extend the period within which the development can commence for a further 5 years at and Adjacent to the Bungalow, Libanus Road, Blackwood has been REFUSED because the applicant has failed to enter into an obligation under section 106 of the Town & Country Planning Act 1990 to ensure the provision of affordable housing at the site at a rate of 25% of the units to be constructed.
