MINUTES OF THE BLACKWOOD TOWN COUNCIL MEETING HELD ON 2ND. JULY 2018

1. Apologies for Absence

Apologies were received from Councillors N Turner, D Jones, A Farina-Childs & J Griffiths together with County Councillor K Etheridge

2. Declarations of Interest

There were no Declarations of Interest made at this point

3. Police Report

The Mayor welcomed PC Kramer Sloman, Ward Manager of Blackwood Neighbourhood Policing Team to the meeting, in the absence of Inspector Drayton.

PC Sloman gave a breakdown of crime statistics for Blackwood for the period to 30^{th} . June 2018 compared with the same period in 2017

The officer then highlighted the various initiatives and issues that had affected / will effect the town over recent/coming weeks

A Youth Day had been organised for 9th. August at the Market Place in Blackwood in an effort to engage with local young people. Borough Outreach workers, St. John Ambulance, The Basement (Blackwood Library) would be in attendance to assist, together with various activities.

Operation Bernie, where the Police, Fire and Local Councils were working together to try and deal with the unfortunate spate of deliberate fires.

There had been one case of Modern Day Slavery

Trading Standards had investigated Scrap Metal Dealers, and 8 vehicles were targeted

Operation Finch, a Regional Organised Crime Unit initiative had resulted in 14 arrests with substantial sentences handed down

Weekly parking operations had resulted in 50 tickets being impose since the start of May & it had been reported residents of David Street had been very pleased with the outcome

Simon Jones, Landscape Officer was involved with an Off road Vehicle Operation which relied much on information and advice from the communities affected

The Velathon would result in many road closures, but it was hoped would be less problematic than previous years

Police presence at the Beach Party Weekend which had proved very successful and trouble free. Members placed on record their appreciation and thanks to the Inspector for the assistance of PC's and PCO's at the event

PC Sloman asked if members had any questions/ queries –

The Chartist Bridge issue was raised, and the officer stated that he would do all he could to ensure Town Council have representation at the MAG meetings in the future.

Members queried the incident in town last week on the High Street, near Wetherspoons. PC Sloman confirmed that a 32 year old man from Blackwood had died, but could not report further as the matter had been referred to IOPC by Gwent Police and an investigation had been launched.

PC Sloman as thanked by members for his full and informative report.

Before leaving the meeting, the officer reminded members of the Ride Along Scheme, where there was an opportunity to experience a day with Police Officers.

Called for a Referendum over Leisure Centre Provision – no support

Request for Zebra Crossing near Blackwood Miners' Institute – Officers say a standalone crossing could only be located north of the BMI as it would be too close to existing junction if installed further south. Existing bus stop/lay by arrangement and entrance to car park effectively means one viable location where the dropped kerbs are provided on the eastern side of the road however in close proximity to the signalised junction at Pentwyn Road. Pedestrian crossings require a number of zig zag markings to be provided which prohibits vehicles to stop, thus sterilising 40 metres of parking in front of BMI, frequently used for drop off of customers. They, therefore, determined the incorporation of a pedestrian phase within the existing signal arrangements would be a better solution rather than a standalone pedestrian crossing facility.

(This solution is still likely to cost £50 K)

9. Verbal Report on Carnival/Beach Party

Councillor Zoe Hammond, Chair of Events, gave a brief report, saying the weekend had been a great success and thanked all members who had attended for their support.

There had been some issues – parking at Bridge Street and stage electrics – but these had been resolved, and she thought best to discuss in more detail at a planned De-Brief meeting.

Members placed on record their thanks to Councillor Hammond for all her time and hard work to ensure the event was a resounding success.

10. Blackwood & District Heritage Association – Update on Coed Duon Project

Unfortunately Granville Hale is not well and has sent his apologies. It was *agreed* to defer this item to the next meeting

11. Chartist Bridge

The Clerk presented copies of correspondence in respect of the Chartist Bridge, and placed on record his thanks to Councillor Darren Jones for his assistance in drafting the Town Council's letter.

Members fully supported the letter and were pleased that CCBC had agreed to a 2 hour meeting with Town Council representatives to discuss our concerns in greater detail.

After some discussion, it was *agreed* that 2 Independent members, 2 Plaid Cymru members and 1 Labour member together with the Clerk attend the planned meeting, and that the Clerk is notified of names as soon as possible.

Councillors Andrew Short & Delwyn Davies had already been nominated previously.

12. Caerphilly C.B.C. Sport & Active Recreation Strategy

The Clerk presented his report which identified parts of the Committee report which highlighted net operating costs of the Centres together with net cost per visit. It proposed that a rationalisation of facilities would result in 4 strategic, high quality, multi service leisure centres managed by the authority's Sport & Leisure Service – located in Risca, Caerphilly, Newbridge and one in the Bargoed/Aberbargoed areas to serve the north of the county borough. It is, therefore, anticipated that the other leisure centres would either transfer to school management (if they are joint use facilities located on a school site, subject to governing body approval) or could close completely.

The Clerk stated he thought it would be in the best interests of Town Council to meet with all Borough members in wards that could/would be affected by closures of Pontllanfraith and/or Cefn Fforest Leisure Centres to ensure the same message gets back to Caerphilly C.B.C. and the general public can see a joint working across political parties.

After some discussion it was *agreed* the Clerk organise a meeting at Cefn Fforest Community Centre inviting County Borough Councillors representing Blackwood, Cefn Fforest, Pontllanfraith, Penmaen, Aberbargoed & Argoed Wards over the next week or so to organise a plan of action against proposed plans of closures.
