# MINUTES OF THE BLACKWOOD TOWN COUNCIL MEETING HELD ON 7<sup>TH</sup>. NOVEMBER 2016.

## 1. Apologies for Absence

Apologies for Absence were received from Councillors M Harris & P Cook

#### 2. Declarations of Interest

No Declarations of Interest were made at this point

## 3. Policing Matters

The Mayor welcomed Inspector White to the meeting.

The Inspector reported that Shop Lifting had seen a relatively significant increase in the area, with ASDA & Boots two of the main targets. Officers had visited the stores and discussed their product placement strategy with a view to moving certain items from near the doors. This initiative together with targeting known individuals did result in a reduction during October, and given the upcoming Christmas period Operation Tinsel has been introduced, with both overt and covert surveillance.

Parking on the High Street has been another problem on the increase, and some 200 tickets were issued over the past weeks.

The Bus Station continues to be a problem area, with one individual arrested 6 times, and this requires longer term management.

At the recent Town Centre Management Committee meeting the problem of car cruisers had been raised, but officers had had no reported incidents during October, but were not complacent and the situation will continue to be monitored.

Regarding Drugs, a warrant was obtained or the High Street and 2 arrests made for possession of Class B drugs, also 30 cannabis plants seized with potential street value of £8,500

There was a planned meeting of the Night time economy group, and the plan was for local officers, supported by street pastors and special constables to be visible in town on Fridays & Saturdays.

The Inspector also reported a significant reduction in problems (approx 70%) associated with Halloween and Bonfire Night due in no small part to the cinema passes initiative.

The priorities identified at the local ward meetings highlighted parking and the bus station to be the most important.

He also informed members that there were 11 Remembrance Services in the area and that all would have a police presence.

Inspector White asked members if they had any issues they wanted to raise –

Councillor M Gwynne referred to the fact that some of the toilets at the bus station appeared to be damaged, but this was identified as a matter for C.C.B.C.

Councillor W Baber referred to a mugging incident that had been reported and apparently captured by CCTV but that the victim had not been attended to - the Inspector stated he would check this out. Councillor Baber also voiced concerns regarding a former employee at the Market Place who still seems to think he has some responsibilities and is regularly on site.

Councillor Jim Edwards stated that whilst there were undoubtedly ongoing problems at the bus station he felt there had been improvements over the past few months.

The Mayor thanked the Inspector for his attendance, and he left the meeting.

# 7. To Confirm the Minutes of the Town Council Meeting held on 3<sup>rd</sup>. October 2016

#### 8. Matters Arising

The Clerk reported the Christmas figurines had been received and lamp posts identified. Furthermore, he had negotiated a 15% discount on the figures quoted at the last meeting, resulting in savings of approx £600.

# 9. To Receive the Minutes of the Policy & Finance Committee Meeting held on 17<sup>th</sup>. October 2016

Councillor Roger Moore declared an Interest at this point being a Committee Member of Blackwood R.F.C., and took no part no the discussion or decision making.

Councillor J Criddle presented the minutes, and after some discussion it was resolved they be received.

In respect of the Council Highway Owned Car Parking Task & finish Group, members agreed the recommendation.

Similarly, they also agreed the recommendation regarding the Report by the Boundary Commission of Wales

It was *unanimously agreed* the following grants be made –

Councillor J Criddle reported that during the signing of the Loan Agreement, Janine O'Callaghan had mentioned that during the refurbishment of the Theatre a significant amount of old memorabilia had come to light, and he had suggested they contact Gwent Archives and the Libanus Lifestyle Centre before deciding to discard anything.

It was agreed that Agenda Item 13 Additional Financial Support be discussed at this point of the Agenda

## 10. To Consider Additional Financial Support to future Velvet Coalmine Literature Festivals

Councillor J Criddle referred members to the copy of the Clerk's Report to Policy & Finance Committee Meeting ( 17<sup>th</sup>. October ) attached to minutes of that meeting, which identified a financial strategy which should ensure Town Council being the main named sponsor of this prestigious event, and the recommendations from that meeting are that -

- (1) Of the ongoing potential savings associated with the Carnival, £500 be earmarked towards the Literature Festival, the remainder (£1,500) invested back into other Events
- (2) £1,500 be earmarked from balances each year for the next 5 years towards the Literature Festival, possibly £750 each from Projects Reserves and General Reserves
- (3) The Precept for 2017/2018 be increased by £1, thus raising an approximate additional £3,000 per annum that be earmarked specifically for the Literature Festival

The resultant effect being to recommend that Town Council becomes the Title Sponsors for the Children's Literature Festival ( with the acceptance of Velvet Coalmine ) in the sum of £7,500 for the next 5 years

After much positive discussion it was *unanimously agreed* the recommendations be accepted, and that Town Council look to sponsor the Velvet Coalmine Children' Literature Festival in the sum of £7,500 each year for the next 5 years.

The Clerk indicated that it was planned to announce this new sponsorship deal at the Civic Awards Evening later in the week.

Councillor Z Hammond presented the minutes and it was *resolved* they be received.

She asked members present to indicate whether they would be attending the Civic Awards Evening, as numbers were likely to be in excess of 150.

was not adopted, since 20% of membership agreement was required, and sufficient numbers were not in attendance.

Councillor Z Hammond reported that rough sleeping was becoming a major problem in the area, with the Night Shelter at Elim Baptist Church already over crowded, which proved the desperate need for single person accommodation.

She stated she was looking to organise a collection of clothing and toiletries for the rough sleepers prior to Christmas, and asked if Town Council would support this initiative.

After some further discussion it was *agreed* Town Council give their support, and if necessary consideration be given to financial support on receipt of an application.
