1. Apologies for Absence

Apologies for Absence were received from Cllrs. P Cook M Gwynne & N Dix

2. Declarations of Interest

No Declarations of Interest were made at this point

3. Police Report

No Police present

4. County Borough Report

Cllr. A Farina- Childs gave an update on the following issues –

Bin collections – total shambles with poor communication regarding delayed or missed collections

Show field - had personally collected some 30+ cans/cartons from the car park

Dog litter bins full to overflowing, being a potential health hazard and when reported to Parks Department over the Christmas break, told they wouldn't be collected/emptied until 2nd. January

Proposed Skate Park - putting to one side the apparent lack of security/ lighting, plans seem to indicate this may not be as all inclusive a park as originally anticipated

Bowls Clubs - original proposals amended, now anticipating 25% of maintenance fees from April'26

Cwmgelli Development – continuing issues with culverts and drainage likely to result in the site not being fully habitable until 2027

Pobl Development – Highway issues mean this development at Coronation Road is currently on hold

Old Somerfield Car park Site - Site problems have delayed proposed start of the development

Homeless persons - There are currently 6 homeless persons in town, with no night shelter currently up and running

Bus Station - Reports of continued problems with youths in and around Bus Station each evening

School Crossing Patrol – Thanks to Cllr Kevin Etheridge for his efforts in ensuring position at Libanus School remains in place

New Nursery on Bridge Street – Reminder of invitation to all members to opening 18th January

5. Mayoral Announcements

The Mayor reported he and other members had received numerous phone calls regarding the Bins issue highlighted by Cllr.A Farina-Childs.

He also reported he had assisted in judging the Best Christmas Window Dressing Competition that had been won by Kismet

Unfortunately, the proposed enhancement scheme to Blackwood High Street Car Park is unable to go ahead in its entirety, due to the fact that although the side lane next to Card Centre is an adopted highway, there is no public right of way through the private car park behind these shops. Improvements will still be going ahead (new bin storage, landscaping and tree planting, removal of side fencing, and bench seating), however we will not be proceeding with the footpath. We will instead be extending the new wall along the perimeter of the private car park above the banking to improve the appearance of this area.

Footfall figures

On 24 October 2024 my predecessor Jacqui Morgan wrote to you regarding the proposal to reduce the number of cameras throughout the Borough.

The e mail outlined the reasons for the reduction and highlighted the camera at the Health Centre in Cefn Fforest that would be affected, asking for your comments.

Comments received from all consultees have been given careful consideration.

The representations received provided no significant new information that leads us to believe that the decision to remove the camera should be reversed.

I would remind you that should circumstances change significantly, then the Authority has re-deployable cameras which can be moved to areas of greater need. Furthermore, the sites where the current cameras are located, will be preserved in such a way that should re-deployable cameras be required, they can be installed.

In response to revised proposals suggested by the Deputy Mayor regarding the potential installation of shutters at the bus bays to try and mitigate the anti social behaviour, a response from Kelly Adams (Integrated Transport Unit) stating the new proposals were impractical and non viable
